



Aluminum Door Model EL100/EL125 Limited Warranty

**Door Sections Five Year Warranty
Hardware & Springs Lifetime Warranty
All Glass One Year Warranty**

Elegant Custom Garage Doors & Gates, Inc. ("Manufacture") warrants Model EL100/EL125 ("Product") to the original purchaser ("Homeowner"), under normal conditions and use for the following periods. Sections are warranted against splitting, cracking or structural failure for a period of 5 years. Powder coat finishes are warranted against cracking or chipping for a period of two years. All hardware components, including springs have a Lifetime Warranty against defects in workmanship. All glass is Warranted for 1-year against stress cracks only. All warranty periods are effective from date of purchase. This limited warranty is made to the original purchaser of the product only and is not transferable or assignable.

Hardware warranty applies only to standard lift and low headroom applications. Custom lift has a 2 year warranty. To maintain Lifetime Hardware Warranty, the door must be professionally serviced once a year.

Manufacture's obligations under this limited warranty are strictly limited to repair or replacement, at its option, any part and component which is determined by Manufacture to be defective during the applicable warranty period. Color variation is inherent in all anodized finishes due to chemical inconsistencies in the anodizing process and are not considered a defect. Laminate glass will lighten over time in direct sunlight.

Weather-strip is not included in this warranty

This limited warranty excludes: any damage to frame, glass or hardware resulting from scratching, abrasion or impact by any hard object, and any fading or color change which may not be uniform due to unequal exposure of the door sections to sunlight or other elements. Damage or deterioration caused by exposure to salt, chemical fumes or other corrosive or aggressive environments, whether naturally occurring or man-made, including, but not limited to, environments with a high degree of humidity, sand, dirt or grease. Damages caused by improper installation or maintenance. This warranty does not apply to any alteration or repair of the Product, or to any Product or component which has been damaged or deteriorated due to misuse, neglect, accident, failure to provide maintenance, normal wear and tear, or any other cause beyond the direct control of the Manufacture.

THIS LIMITED WARRANTY EXCLUDES THE MANUFACTURE FROM BEING HELD RESPONSIBLE OR LIABLE FOR, COLLATERAL, PUNITIVE, INDIRECT, INCIDENTAL OR CONSEQUENTIAL DAMAGES, even if Manufacture has been advised of the possibility of such damages. Such excluded damages include, but are not limited to, death, injury, damages to property, or damages occurring from loss of use of any product, property or facility, loss of goodwill, loss of profits, cost of any substitute product, interruption of business, or other similar indirect financial loss. **ALL OTHER WARRANTIES, EITHER EXPRESS OR IMPLIED, INCLUDING WARRANTY OF MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE, ARE EXCLUDED.**

In the event of a claim under this warranty, contact the installation dealer promptly after discovering the defect. Continuous use of a defective product could result in the void of this warranty. The manufacturer reserves the right to inspect all products alleged to be defective and to verify eligibility of this limited warranty. Proof of the purchase and/or installation date, and identification as the original dealer, may be required.
